



# THE JIM MCKAY TURF SPRINT \$100,000 Guaranteed

(Includes \$50,000 from the Breeders' Cup Fund)

**FOR THREE-YEAR-OLDS AND UPWARD** By subscription of \$100. \$250 to pass the entry box. \$250 additional to start with \$50,000 Guaranteed, and an additional \$50,000 from the Breeders' Cup Fund for Cup nominees only. The Host Association's added monies to be divided, of which 60% to the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. Unearned purse money is split between the horses that start and finish the race. Breeders' Cup Fund monies also correspondingly divided provided a Breeders' Cup Nominee has finished in an awarded position. Any Breeders' Cup Fund money not awarded will revert back to the fund. Supplemental nominations of \$750 each will be accepted by the usual time of entry with all other fees due as noted. Weights: Three Year Olds, 120 lbs.; Older, 124 lbs. Non-winners of \$60,000 in 2009 allowed 2 lbs.; of \$50,000 in 2009, 4 lbs.; of \$40,000 in 2009, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). Preference to Breeders' Cup nominees only of equal racing quality or starters with highest career earnings in 2008-09 on the Turf. Horses may be placed on the also-eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the winning owner given by the Breeders' Cup Ltd.
