FOR FILLIES AND MARES, THREE-YEARS-OLD AND UPWARD By free subscription. \$250 to pass the entry box. \$250 additional to start with \$50,000 Guaranteed, of which 60% to the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. Unearned purse money is split between the horses that start and finish the race. Supplemental nominations of \$500 each will be accepted by the usual time of entry with all other fees due as noted. Weights: Three Year Olds, 120 lbs.; Older, 124 lbs. Non-winners of \$60,000 in 2009 allowed 2 lbs.; of a race of \$50,000 in 2009, 4 lbs.; a race of \$40,000 in 2009, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). Preference to starters with highest earnings in 2008-09. Horses may be placed on the also-eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
