Free to start, with \$150,000 Guaranteed, of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Supplemental nominations of \$1,500 each will be accepted by the usual time of entry with all other fees due as noted. Weights: Three-Year-Olds, 119 lbs.; Older, 124 lbs. Non-winners of \$70,000 twice at one mile or over in 2018, allowed 2 lbs.; \$70,000 once at one mile or over in 2018, 4 lbs.; \$60,000 at one mile or over in 2018, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). Preference to starters with highest career earnings in 2017-2018 on the turf. Horses may be placed on the also eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
