Supplemental nominations of \$1,000 each will be accepted by the usual time of entry with all other fees due as noted. Weight: 122 lbs. Non-winners of \$60,000 twice at one mile or over, allowed 2 lbs.; \$60,000 once at one mile or over, 4 lbs.; \$50,000 at one mile or over, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). Preference to starters with highest career earnings on the turf. Horses may be placed on the also-eligible list. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.
