Use your card every time you make a wager either through a teller or a self-service terminal.

CARDS

Your membership card will be issued upon completion of the Premier Player Application and presentation of valid identification. *If a card is lost or stolen more than three times, the fourth card and any additional cards will be issued with a \$5.00 service charge.*

For Maryland Thoroughbred wagers, you receive: 1 point for each \$1 wagered with a teller; 1 1/2 points for each \$1 wagered through a self-service terminal.

PREMIER PLAYER PLUS VIP PROGRAM

Players whose monthly wagers at Laurel and Pimlico total \$10,000 or more will receive month-end bonuses on non-Maryland races as outlined below:

To redeem your points, please visit the Guest Services counter at Laurel or Pimlico, on Maryland live racing days only. *Valid identification is required to redeem prizes.*

FREE ADMISSIONS

Card holders will receive free admission to Laurel and Pimlico all racing days except

Free admission days are subject to change with alteration of the weekly racing schedule.

SEASON PASS HOLDERS SHOULD NOT USE THEIR PREMIER PLAYER CARD FOR ADMISSION. PREMIER PLAYER CARDS CAN NOT BE USED AND POINTS CAN NOT BE REDEEMED PREAKNESS DAY.

RULES

- 1. Must be 18 years of age or older to participate.
- 2. Membership is limited to one account and one card per person. Members may not share accounts or share, loan, or distribute membership cards. Combining wagering activity will result in membership termination and forfeiture of all points. Membership cards, accounts and points are non-transferable and may be revoked, repossessed, modified or cancelled at any time at the sole discretion of the Maryland Jockey Club ("MJC").
- 3. Cards may not be left with a mutuel clerk at any time.
- 4. It is the Member's responsibility to properly insert the membership card into the terminal when placing a wager at a self-service terminal. When using a self-service terminal, you must insert a winning ticket or cash youcher prior to inserting your Premier Player card and placing the wager. Failure to insert the card correctly will result in non-accumulation of points and Members will not benefit from play. Points will not be issued for any claims involving wagers from printed tickets or faulty card readers.
- 5. Inactivity (no wagering associated with your account or membership card) for a 6 month period will result in deletion of your account and forfeiture of any and all accrued points.
- 6. Employees of MJC or its affiliates are not eligible to participate.
- 7. Management of MJC will review any disputes regarding this program. Management decisions are final and binding.
- 8. Premier Player points have no cash value. Rewards may change and certain prizes may be offered on a limited basis and for a limited time. Rewards are based on availability. Once points are redeemed, redemption is considered final and irrevocable.
