ROSE BRIER stalked the pace, advanced two wide leaving the far turn, took command in upper stretch, lugged in near the eighth pole and was ridden out.

SPECIAL ENVOY , bumped by WILLISVILLE leaving the starting gate, saved ground the first turn, swung outside in upper stretch and rallied. CAT

FIFTYFIVE sped to the early lead, set the pace along the rail and weakened. THUNDERINWILLIE , well back turning for home, had a late rally. OFFICER'S

OATH was not a factor. WILLISVILLE bumped SPECIAL ENVOY when bearing out leaving the starting gate, swung out entering the stretch and gave way.

GUMPER , fractious in the post parade, chased the pace, was rank on the backstretch and gave way.
